Actions and activities in Q3/2017

Valmet maintained its position among the world's sustainability leaders with the inclusion in the Dow Jones Sustainability Index (DJSI) for the fourth consecutive year. Valmet was listed both in the Dow Jones Sustainability World and Europe indices (see [press release](#)). Furthermore, Forum ETHIBEL informed us that Valmet was reconfirmed as a constituent of the Ethibel Sustainability Index (ESI) Excellence Europe. Proud of these acknowledgements, we also believe that they make life a bit easier for you as an investor. Announcements during Q3/2017

On September 6, Valmet announced the composition of its Nomination Board. The largest shareholders' representatives are Antti Mäkinen, Managing Director, Solidium Oy; Satu Huber, CEO, Elo Mutual Pension Insurance Company; Risto Murto, President and CEO, Varma Mutual Pension Insurance Company and Timo Ritakallio, President and CEO, Ilmarinen Mutual Pension Insurance Company. Bo Risberg, Chairman of the Board of Directors of Valmet, will serve as an expert member.

On September 1, Valmet announced its financial result publication dates for 2018:
February 6, 2018 - Financial Statements Review for 2017
April 27, 2018 - Interim Review for January-March 2018
July 25, 2018 - Half Year Financial Review for January-June 2018
October 23, 2018 - Interim Review for January-September 2018
AGM will be held on March 21, 2018 and the Annual Report will be published on week 9 latest.

On August 10, Valmet announced that it had received a notification referred to in Securities Market Act from BlackRock, Inc, stating that the company's ownership and share of votes in Valmet Oyj has exceeded the threshold of 5 percent. As a result of share transactions on August 8, 2017, the holding of BlackRock, Inc increased to 7,559,076 shares, representing an ownership of 5.04 percent of Valmet Oyj's total number of shares and share of votes.

On July 28, Valmet announced changes in its Executive Team. Following appointments have been made as of October 1, 2017: Jukka Tiitinen - Area President, Asia Pacific; Aki Niemi - Business Line President, Services; Hannu T. Pietilä - Vice President Sales, Asia Pacific. The recruitment of new Area President, China has started.

On July 27, Valmet published its Half Year Financial Review January 1 - June 30, 2017.
