Events in Q3/2019

Pekka Rouhiainen started in his position as Director, Investor Relations, at Valmet as of September 1, 2019. For the past years, Pekka was employed as Investor Relations Director at Cargotec Corporation. He has previous investor relations experience from Sanoma Corporation and worked as an equity analyst before joining Sanoma.

Valmet will publish its Financial Statements Review, Half Year Financial Review and two Interim Reviews in 2020 as follows:

February 5, 2020 - Financial Statements Review for 2019

April 23, 2020 - Interim Review for January–March 2020

July 23, 2020 - Half Year Financial Review for January–June 2020

October 27, 2020 - Interim Review for January–September 2020

The Annual Report for 2019 will be published during the week starting on February 24, 2020 (week 9) at the latest.

Valmet has been included in the Dow Jones Sustainability Index (DJSI) already for the sixth consecutive year. The company was listed both in the Dow Jones Sustainability World and Europe indices. The comprehensive ranking evaluates companies' economic, environmental and social performance. The total number of companies included this year in the DJSI World is 318.
